ISSUES AND RISKS

This SDAP is a strong indication of the Cabinet Office's commitment to delivering its core functions sustainably. In particular, it is encouraging to see plans to explore embedding sustainability into Capability Reviews and the personal objectives of staff. Such plans should be seen as part of a broader aim to mainstream sustainable development within government and the wider public sector, and the SDC would like to see the Cabinet Office strengthen its role here in order to achieve its purpose of 'making government work better'.

The SDAP has also laid out some important intentions towards mainstreaming sustainability throughout the work of the Office of the Third Sector (OTS). However, there could have been far greater recognition of the role that OTS has across government, to ensure the third sector has a voice within government. How, for example, will the Cabinet Office work to ensure that third sector experience and expertise is sufficiently utilised in policy making across government? A future SDAP could make clearer how this is being achieved, and also set more ambitious actions for engaging other departments in the work of the OTS.

CO'S RESPONSE

"The Cabinet Office welcomes the Sustainable Development Commission's assessment of its Sustainable Development Action Plan for the period 2009-2012.

There is a great deal of work underway within the Department on a number of areas which will have a positive impact on sustainability both domestically and across the wider Government; particularly around the green ICT agenda and carbon reduction. The Department will seek to provide greater coverage of these significant endeavours in future SDAPs and we are confident that, as a result, future assessments will reflect our efforts. The Cabinet Office will be reviewing and updating this 3-year SDAP throughout its lifespan and will use these opportunities to bolster the document and incorporate the SDC's recommendations, particularly ensuring that the work of the Office of the Third Sector is given greater prominence as well as providing greater detail of how the document impacts upon the Department's Executive Agencies and Non-Departmental Public Bodies.
