# ISSUES/RISKS

It is clear that Cefas is engaged with the sustainable development agenda and has put considerable efforts into the strategic planning side of its SDAP. However, two concerns were raised through the assessment process:

- Part of Cefas' remit is to promote sustainable management of natural resources, and it does therefore have a responsibility to apply this to its work on fish stocks. While the SDAP did refer to its work on the monitoring of fish stocks, their sustainable management was not discussed within the SDAP
- Cefas' relationship with the FSA could have been outlined more clearly as there is some overlapping work between the two. Collaborative working with FSA is strongly encouraged to ensure policies across government are consistent.

# **CEFAS' RESPONSE**

"Cefas believes the reality of our sustainability performance is stronger than the assessment suggests. This encourages us to improve our presentation. Cefas makes a significant contribution to the sustainable management of UK and international fish stocks in many ways including:

annual production of Defra's report on Finfish Stocks and their exploitation and the Fish Stocks indicator
support for Seafish, providing information on nine species covered by their Responsible Sourcing Guides

- expert advice to Ministers in EU stock and quota negotiations as active members and leaders within <u>ICES</u>, to further co-ordinate and promote marine research delivery of EU and internationally funded research on the climatic, environmental, social and economic impacts on, and of, fish stocks.

- Cefas assists the development of consistent policies across government, for example: our FSA work assessing the microbiological quality of shellfish assists Defra's sewerage discharge and shellfish bed location policies our Defra sustainable fisheries work underpins FSA's seafood consumption and sourcing policies.

Operationally our highest priority and greatest long-term sustainability impact is the renewal of our office and laboratory facilities at Lowestoft (the Waveney Campus). This will provide <u>BREEAM excellent</u> facilities for 75% of our total operations (expected in 2011)." (Cefas, September 2008).


