

Introduction

This Action Plan 2009 sets out our sustainable development targets and key actions going forward until 2012. It is updated and reported against annually and will be revised to take account of SOGEII targets when these are published.

Actions to assist the department in delivering Public Service Agreement 30 (Global and regional reduction in conflict and its impact and more effective international relations) are detailed in <u>Defence Plan 2009-13</u>, and are captured as the high level objective 4.1 in this Action Plan.

Sustainable development provides a supporting Performance Indicator for the third of MOD's three Departmental Strategic Objectives: Build for the future. It is assessed against the achievement of objectives for sustainable consumption and production, climate change and energy, natural resource protection and environmental enhancement and sustainable communities, and reported on on the MOD's Annual Report and Accounts.
