## **ISSUES AND RISKS**

It is encouraging to see that ECGD positions itself as a proponent among international Export Credit Agencies in improving standards and practices. This could be built on further by stating how the department intends to raise ambition levels internationally, and by setting out what sustainable lending practices look like and how they can be implemented.

As with all government departments ECGD has a responsibility to be aware of the contribution its projects make in terms of social, economic and environmental impacts and to ensure its activities are not in conflict with government's sustainability goals. For example, ECGD could play a key role in exploring with HMT (whose consent the department operates under) where the barriers lie in supporting environmental technologies and cleaner energy sources as part of government's low carbon drive.

ECGD is currently working on its 2010-2012 SDAP and the SDC looks forward to working with the department through this process and following its progress.

## **ECGD'S RESPONSE**

ECGD is disappointed to receive a red rating from the SDC for its 2009-11 (SDAP). ECGD considers that such a rating does not reflect the evidence provided by ECGD to the SDC on: \* ECGD's commitment to sustainable development (as reflect, for instance, in its 5 Star rating from the SDC in the *Sustainable Development in Government* assessment of April 2009 in respect of the operational targets for central government departments set out in the *Sustainable Operations of the Government Estate* for 2007/08); or \* The leadership role ECGD plays, as internationally recognised, in promoting sustainable development within the international export credit community; or \* ECGD's primary role as defined by statute, which is to support UK trade; or \* ECGD's obligation to comply with the financial objectives set for it by HM Treasury under its Consent; or \* ECGD's policy remit as prescribed by Ministers, which includes pursuit of a level playing field on official support trade internationally while taking into account the Government's international policies on sustainable development, for which other departments carry lead responsibility; or \* The way in which all decision-making by ECGD on support for new transactions takes into account its obligations to comply with OECD agreements governing official export credit agencies, and with its published policies, in respect of sustainable development. \* ECGD recognises, however, that its SDAP could benefit by being clearer in certain respects, particular where it has a good story to tell, such as on Procurement, Operations, and SDAP Ownership, Engagement and Review. \* ECGD will prepare a new SDAP for 2010-12 for this purpose and will seek the SDC's advice on it before it issued.
